MAINTENANCE CHECKLIST

All of the following wear points should be checked on a monthly basis and recorded on the checklist enclosed. Contact Southpaw for repair or replacement of worn or frayed parts.

- Check all seams for rips or tears. If rips or tears are found, discontinue use immediately until repaired to keep clients from ingesting foam.
- Check zipper to be sure it is closed properly. Zipper cannot be repaired except by Southpaw because the zipper slider was removed to prevent having a hard or sharp place on the foam.

STORAGE PROCEDURES

- Store out of direct sunlight.
- Store away from all chemicals and household cleaners.
- Store where not accessible by clients without proper supervision.

CLEANING INSTRUCTIONS

- Check with your infectious disease department before using these procedures.
- Check for client allergies first.
- Clean with a damp cloth using soap and water or disinfectant.
- Dry before using.
- Do not immerse in water.

- Check all seams for loose or missing stitches. If loose or missing stitches are found, discontinue use until repaired. Contact Southpaw for repair or replacement.

- Keep away from all chemicals and household cleaners.
- Store where not accessible by clients without proper supervision.

CLEANING INSTRUCTIONS:

- Check with your infectious disease department before using these procedures.
